

**NASCAR Heat 2 Speedway Motorsports, Inc. \$50 Ticket-Coupon Promotion**  
**PROGRAM TERMS AND CONDITIONS**

**1. Eligibility:** NASCAR Heat 2 Speedway Motorsports, Inc. \$50 Ticket-Coupon Promotion (the "Program") is open to legal residents of the fifty (50) United States (including D.C.), eighteen (18) years old or older at the time of entry. Void where prohibited.

Open the package and locate the insert. The insert will include a unique offer code.
